1.01 DESCRIPTION OF PROJECT

- A. Rockford Public Schools (Owner) is requesting quotations regarding the implementation of a single Internet Service Provider to service the entire school district.
 - 1. Connection shall be made to the Owner's existing network head end in the Rockford Freshman Center located at 4500 Kroes Street, Rockford, MI 49341.
 - 2. Coordination with Owner's Operational Technology staff and existing service provider during all cut over activities shall be the sole responsibility of the selected contractor.
 - 3. Bandwidth required by Owner shall be evaluated and may, or may not, be adjusted at six (6) month intervals of the contract period to Owner designated rates per the table in Section 1.04. Contractor shall provide for bandwidth change, based on monthly recurring rates provided as response to this request within 60 days of notice by Owner. Initial one-time fee will only apply to the initial contract build out for the first rate elected. No one time fess will be applicable for the Owner designated rate changes for the circuit.

1.02 PROJECT REQUIRMENTS

- A. Contractor responding to the RFQ must have a minimum of two (2) years of experience with current quoted solution.
- B. Assigned Contractor Representative must have at least 3 years of project experience with similar scope of work.

1.03 SCOPE OF WORK

- A. Any cost for construction necessary to make full and final connection to Owner's network infrastructure shall be the sole responsibility of Contractor. Contractor shall carefully coordinate any such construction activity with Owner's designated Construction Manager personnel.
- B. The contractor shall present a quotation that includes detailed information about the implementation and cut over testing tasks, milestones and conversation steps.

C. IMPLEMENTATION APPROACH

- 1. The selected Contractor will work with Owner/Designer on a regular basis, in person or by phone, to plan, prioritize, design and implement the system.
- 2. As part of this RFQ, the Contractor shall submit a project plan that includes:
 - a. The estimated timeline to deliver the solution include performance milestones.

- b. The names and roles of professional staff that will be assigned to the project.
- c. Any specific requirements the selected Contractor has of Owner resources.
- d. Explain in detail post-implementation support.

1.04 PROPOSED PRICING

- B. Pricing shall include a 3-year contract. All monthly recurring prices must be fixed for 36 months.
