Project Questions and Answers:

This document provides answers to questions asked by bidders who have reviewed the Technology Request for Bid for the above referenced project.

Q1	Do you want a Stainless-Steel Decora Plate at the HDMI Transmitter Location?
A1	Where applicable, yes. (27.41.61-65; J- 2- B)
Q2	Are we required to provide the cut-in locations?
A2	The only “cut in” expectations are that of the classroom speakers, as noted in the RFP.
Q3	What is the wall material?
A3	Generally, the wall conditions will be either cinder block, or drywall.
Q4	Will there be any wire mold required?
A4	There will be some surface mount raceway required, depending on the particular configuration, as noted in the RFP.
Q5	Will there be cable Pathways?
A5	Yes, where applicable. See the bid documents for detail.
Q6	Where will the Document camera be located for Configuration B?
A6	All document cameras will be located at the teacher’s work station.
Q7	Who is responsible for the Power Outlet at Projector, Ceiling Enclosure Locations?
A7	Others. See the specific language on this topic in the bid documents.
Q8	Which Network will the Screen Beam Connected to; Wireless or Hard Wired?

A8	Wireless network.
Q9	Will the doc cam connect to the room pc via USB?
A9	Yes.
Q10	Do you want any sort of control system for the Displays or will you be using remote controls?
A10	Control systems are not specified for any category of this project.
Q11	Do you want the Vaddio Doc Cam to display on both Displays in Config. F, or just one?
A11	Both displays- See 27.41.16- 51 B-5.
Q12	What is the speaker count in H?
A12	There are no speakers shown for this location on the appendix, therefore a perspective bidder would not include new speakers for this configuration.
Q13	Is this project Tax Exempt?
A13	Anchor Bay School District is a tax exempt organization in the state of Michigan.
Q14	The OWI MA8764 has been discontinued. Will the MA6760 work as the replacement?
A14	Since the M6760 appears to meet/ exceed the specifications of the M8764, this would be an acceptable alternative.
Q15	S130 has two Config A in the drawing. Is this correct or a misprint?
A15	Perspective bidders should assemble their proposal based on what is requested in the bidding documents, and shown in appendices as published.
Q16	S114 does not have a system listed. Is this correct?
A16	Please see Q/A 15.
Q17	Do you have a count of each configuration?
A17	Please see Q/A 15.
Q18	Can we use a different cord reel on the Config B Cart?
A18	As long as the cord reel you include meets or exceeds the specifications of the

	unit used as the design reference in the bidding documents, yes.
Q19	Per the Walk through the expectation of the Doc Cam in Config. F is supposed to be PTZ. (Pan Tilt Zoom) The specs have one that is Zoom only. Would you like to provide a part number or a functionality set up so we can provide a camera that meets your needs.
A19	Please see Q/A 15.
Q20	Please verify if the school will provide a lift as required.
A20	Confirmed.
Q21	For configuration H, the location of the projector and screen are not indicated on the floor plans provided, can we get some guidance on that?
A21	Please see Addendum #1.
Q22	On page 72 it states " All cables shall be proper and adequately supported using hooks or rings no more than eight feet (5') apart. Cables supported by structural steel, ceiling grid or hanger wires will not be acceptable. All cable routing shall be neat and orderly. " Can you please confirm that this is 5'?
A22	Confirmed.
Q23	Is a Performance bond mandatory, or will the bid security be sufficient?
A23	A performance bond and bid security are both required for this project, as specified in the bidding documents.
Q24	Is the district open to demo-ing our IFP solution?
A24	The Owner is certainly open to demonstrations of any equipment that meets the specifications outlined in this project. Demonstrations will be scheduled for products of interest after bids are opened and reviewed.
