| Q1 | In looking at the pictures that I took at the pre-bid, some of my associates had a concern about some of the materials on the ceiling and walls. Can you confirm whether the materials shown in the attached picture contain asbestos? If so, what is the proposed plan to affix conduits to the ceilings and walls where these materials are located? |
| A1 | An installation in 2019 showed no asbestos in those locations. |
| Q2 | Raceway at display locations, who is responsible for moving power to these locations? |
| A2 | The Multimedia Contractor or a subcontractor of the Multimedia Contractor. |
| Q3 | Does the district want the PC modules to be unactivated or activated? |
| A3 | Unactivated for the base price. Include the option for an activated PC module and any associated licensing. |
| Q4 | What brand and model are the current extenders in place for HDMI and USB? |
