Where classroom speakers are to be installed in drop ceilings, they shall be near flush mount and cleanly cut into available tiles for optimal and uniform audio fill of the relevant classroom space. Speakers shall meet or exceed the following minimum standard requirements:</p> <p>1. 6" driver; 1" horn per speaker</p> <p>2. Frequency response: 40 Hz – 20 kHz</p> <p>3.
