## Project Questions and Answers:

*This document provides answers to questions asked by bidders who have reviewed the Technology Request for Bid for the above referenced project.*

<b>Q1</b>	I noticed in the RFP, there are 14 sites, but there's only 10 drawings. Are there drawings for each individual site?
<b>A1</b>	Reference Appendix B, C, D, and E.
<b>Q2</b>	I see we're moving the existing card readers from the Vanderbilt platform to the Genetec platform. Do you know what kind of Card Readers the current system is using? HID, Signo, etc.
<b>A2</b>	The standard card reader is XceedID PR10.
<b>Q3</b>	Who is supplying the locking hardware?
<b>A3</b>	For Appendix B, locking hardware shall be provided by security integrator. For Appendix C, D, and E, locking hardware shall be provided by construction door hardware contractors.
<b>Q4</b>	Who is cutting the doors to fit the locking hardware?
<b>A4</b>	For Appendix B, doors shall be cut to fit locking hardware by security integrator. For Appendix C, D, and E, doors shall be cut to fit locking hardware by construction door hardware contractors.
<b>Q5</b>	Which doors are getting door releases?
<b>A5</b>	Reference Appendix C, D, and E.
<b>Q6</b>	Any video intercoms to be added or upgraded?
<b>A6</b>	There are not any identified as part of this project.

<b>Q7</b>	Are there drawings for Site #6, #7, and #13? If not, what are the counts for these locations? There is a drawing for Bussey Center. The building address is 24501 Fredrick St, Southfield, MI 48033, but there's nothing in the RFP about it. Why was this drawing included, but the site is not listed in the Sites of Work?
<b>A7</b>	Reference Appendix B, C, D, and E. See Addendum #2
<b>Q8</b>	What kind of Genetec system is currently in place?...So we can expand it.
<b>A8</b>	There is not a Genetec system currently in place.
<b>Q9</b>	Are you using mobile credentials?
<b>A9</b>	Mobile credentials are not currently being used.
<b>Q10</b>	Can you explain the Panic buttons? You want them integrated with access control or with the alarm system?
<b>A10</b>	The "panic button" should be integrated with the access control system.
<b>Q11</b>	Do we need to include a lift at each site?
<b>A11</b>	The need of a lift for this work shall be determined by the contractor.
<b>Q12</b>	What kind of Video system do you currently have?
<b>A12</b>	Milestone
<b>Q13</b>	What kind of intrusion alarm do you have?
<b>A13</b>	Honeywell Vista
<b>Q14</b>	Has any of the locations transitioned the card readers from the vanderbilt set up, to the Genetec setup? What type of card readers replaced the old ones?
<b>A14</b>	The system has not transitioned from Vanderbilt.
<b>Q15</b>	Who is providing the locking hardware? Security integrator, or Door Contractor?
<b>A15</b>	For Appendix B, locking hardware shall be provided by security integrator. For Appendix C, D, and E, locking hardware shall be provided by construction door hardware contractors.
<b>Q16</b>	Who is cutting the doors and frames to fit the electric strikes and latches?
<b>A16</b>	For Appendix B, doors shall be cut to fit locking hardware by security integrator.

	For Appendix C, D, and E, doors shall be cut to fit locking hardware by construction door hardware contractors.
<b>Q17</b>	Are the door frames solid (Concrete filled), or hollow?
<b>A17</b>	The majority of exterior doors are solid.
<b>Q18</b>	Will we need conduit? If so, for which doors?
<b>A18</b>	All of Appendix B will need conduit/raceway. Appendix C, D, and E will have pathways provided by construction.
<b>Q19</b>	Will there need to be any fire tie ins?...I.e. Magnetic locks?
<b>A19</b>	There are not any identified in the project at this time.
<b>Q20</b>	What is the total reader count per location? Completely new vs. Card Reader swap outs. Most sites are drop ceiling, correct?
<b>A20</b>	Reference Appendix B, C, D, and E.
<b>Q21</b>	Would you allow the Aiphone access control solution to be considered for this project?
<b>A21</b>	If the specifications described in section, 28 10 00 2.09 Central Management Software are met, the district will consider this solution.
